THERE MAY BE OTHERS

Charley Vernon Stanley's name will be added to the *Vietnam Veterans Memorial* in May 2015, nearly 47 years after his death.

Approved by the *Department of Defense* in Spring 2014, this Casualty has been on my lists of our regiment's deaths from the *Vietnam War* since Summer 2006 when the *Coffelt Database Team* obtained his Service Record that showed Sgt. Stanley was evacuated from Vietnam to Brooke Army Hospital in Ft. Sam Houston, Texas, and died shortly thereafter.

Sgt. (E-5) Stanley was born 6 April 1927 and left CONUS for Vietnam 11 April 1968, where he was assigned to Charlie Co, 2nd Bn (Mech), 22nd Inf Regt, 25th Inf Div. Regular Army, MOS 11B, he came down with Malaria and was evacuated from Vietnam after 16 June 1968 and admitted to the stateside hospital on 1 July 1968, where Sgt. Stanley died of pneumonia, malaria and renal failure on 7 July 1968 at age 41 and after more than 13 years military service. Buried at Oak Shade Cemetery in Cleveland, TX, he was survived by a wife, son age 3, and daughter age 1. His Vietnam unit, Co C 2 Bn 22 Inf Div (sic) appears on his grave marker.

Anyone who remembers Sgt. Stanley's brief service in C Co should contact me (bradhull@juno.com or 440-871-8975).

This is not the first such casualty from our regiment to be added to the *Wall*. Pfc **William Joseph Scannell's**, name was added in May 2003, mainly due to the efforts of D 3-22 Locator extraordinaire Jerry Giannopoulos. Jerry had tried to locate his platoon-mate and connected to Bill's Chicago area classmates who knew he'd died. Pfc Scannell was WIA 28 Aug 68 (gunshot head wound) at FSB Buell while serving in D Co 3rd Bn 22nd Inf Regt. Evacuated from Vietnam, Bill died 12 Sept 70 in a VA Hospital in Downey IL, reportedly without ever regaining consciousness. He is buried at Queen of Heaven Cemetery in Elmhurst IL and remembered on Line 20, Panel 44 of the *West Wall*. Jerry attended the ceremony at the *Wall* when Bill's Name was added.

PURPLE HEART INFORMATION SOUGHT

Just a note to let you know of something that I learned about through the Department of New York Offices of the American Legion. It's called The National Purple Heart Hall Of Honor, and it is located in Vails Gate, New York. I checked them out and sent my info in to them, and I'm now listed on their Roll Of Honor. I thought this might be something that could be sent out in the Newsletter, inviting any of our buddies who received the PH, to check out their website. This organization is a New York State facility, administered by the Palisades Interstate Park Commission. The only way they have to get the needed documentation about PH recipients, is from the Vet or his/her family members. They DO NOT share any of the Vets personal info other than the narrative they ask you to send in about the action in which you were awarded the PH. According to them, only 197,000 of the estimated 1.8 million Purple Hearts awarded since 1932, appear on the Roll. So they are asking for help in getting the word out. You can check them out at www.thepurpleheart.com.

FIRST DAY IN THE FIELD

I remember it being pretty hot...but then all the days were. We newbie's went out into a field in Cu Chi where we stood in a long line (what else?) and as we passed soldiers handing out flax jackets, bandoleers, helmet, and one each, M-16. No writing down each person's name and the weapon's serial number or if they did, I didn't see them. It was just - here you go troop! I remember thinking where do we sight these babies in at? And the answer was nowhere. Perhaps if the NVA charged us we could fire three rounds and see what a tight group they were. But I went

into the field only knowing what direction my bullets were going - not if they hit anything. Course the Army never asked me if I could shoot straight...they just wanted to know if I was breathing.

I remember climbing aboard a deuce and a half and heading out into who knew where on a dusty dirt road as part of a convoy. It was probably the daily convoy which included water and ammo and whatever else the company needed. I was glad the jungle was far away from the road. It seemed like a good quarter mile away so there was no chance of any ambushes. (Nice try Pete but no cigar!) We pulled into FSB Wood and a bunch of us jumped down to meet our new platoons. **Steve Cramp** and I were 11B20's and so they told us brought us to the fourth platoon area and wished us a good tour.

Someone grabbed Steve and he went off in another direction and I was told to join a particular group that was watching us dismount. They immediately began complaining and said they had no room for me. Actually there were already four guys to this mortar track and there really wasn't any room for me. They were cramped as it was trying to sleep four in the track and now they had a fifth body! But someone with authority came over and told them to live with it and I was grudgingly accepted. "Fine," I thought, "I come half way around the world, get placed into a running war, and my side doesn't even want me!"

To get me out of their hair for awhile so they could cool off, **Rudy Saldoval** came over and walked me to a bunker. He had me sit in the right direction and said to remove my shirt but for only 10 minutes, as I was lily white. Remember you could always tell the new guys by how white they were? I sat staring at a tree line way far away for the rest of the afternoon. Supper was brought out to me by some guy and I sat there till I couldn't see anything anymore. Out in the boonies when it got dark...it was dark! Not one street light to guide the way! Someone replaced me and I went back to the 4-1 tract area.

A canvas tarp was rolled out from the track, out

about 10 feet and then down to the ground. Two lawn chairs were there and that was my bed for how long I can't remember. I had shelter from two sides and the top but one heck of a draft could blow through that 10 X 10 foot opening from the other two sides. When it rained I was as wet as the ground. I was given a wool blanket but no pillow and they said they'd see me tomorrow.

Sitting in those lawn chairs trying to get semi-comfortable, I was not the happiest person in Vietnam. But I was still alive and that was a good thing. So I decided to stay and see what the next day would bring...

Would like to hear what your first day out in the field was like...send it in.

VISITS FT. POLK TIGERLAND

January 18-20 2015 **Skip Fahel** (B Co RVN 1967-68) and I (both self-proclaimed members of the "Old Goat Squad" of the Society) were honored to be imbedded with the 1st Brigade Combat Team (1BCT) & Triple Deuce conducting

exercises with the Joint Readiness Training Center (JRTC) at "TIGERLAND" Ft Polk, LA. Skip and I both took Basic at Ft Polk and then on to TIGERLAND. Skip in 1965 and me in 1968.

Triple Deuce Cdr LTC **Rob Schexnayder** and new CSM **Robert Fortenberry** had made hasty arrangements with JRTC Task Force (TF2) Cdr LTC(P) **Jeremy Schroeder** to get us imbedded with the battalion. The term used, we would later learn, was "inside the box" or inside the "real world" play area of operation (AO). Skip and I were provided two escorts during the two days we were there, TF2 Cpt **Caleb Ling** (whose dad served with 1/22 Infantry 1983-85) and 2/22 S-1 Cpt **Reggie Stewart**. Both were outstanding!

I had driven over from San Antonio and picked up Skip in Houston on Sunday morning on the way to Ft Polk. Upon arrival on post our first stop was the Starbuck's at the PX. As we awaited Cpt Ling and Cpt Stewart's arrival we loaded up on coffee and sweets and had the pleasure to visit with many active duty soldiers at the PX. We were supposed to be cleared by Post G-2 but TF2 arranged for that to be waived Cpt Ling took Skip and me over to the highly secure JRTC Joint Ops Center (JOC) for a specially prepared concept brief for us where he shared what 1st Brigade of 10th Mountain Division would be doing over the next ten days and introduced us to many of those working that Sunday. As imagined JRTC JOC is a 24x7 operation.

After the briefing Cpt Stewart arrived and he and Cpt Ling took us over to North Fort Polk's infamous TIGERLAND. I anticipated things would have changed a lot since 1968 but really was not expecting the only thing left of our old TIGERLAND was the sign, which had been modified to conjunction with today's mission of the area. (NOTE: We took a few photos under the TIGERLAND sign and Cpt Ling even drove us thru the streets to see if we could find any landmarks. Gone were all the WWII wooden barracks, gone the wooden mini PX with the juke box in the cor-

ner, gone the wooden movie theater...gone was the Vietnam era TIGERLAND!

After getting clearance to go "inside the box" I rode with Cpt Ling and Skip with Cpt Stewart. Over the next two days it would be great for me to hear the radio traffic, observations and evaluations of the Officer Controllers (OCs) working with Triple Deuce both at battalion and individual company level. I was sworn to secrecy of what I was hearing but after the fact I had a chance to whisper some positive feedback to LTC Schexnayder and CSM Fortenberry on the good things coming out about Triple Deuce's performance and morale.

We moved into the battalion Tactical Operations Center (TOC) in mid afternoon and met with XO Major **Colin Mahle**...soon to become the new 1BCT S3. It was spooky to be back again amongst the tall pine trees. XO introduced us to new Triple Deuce CSM Robert Fortenberry who took us over to visit with Golf Company support elements. (Many of them wanted to know where **Jim May** was? We told them he would see them at Ft Drum in February.) CSM then took us over to meet with the Triple Deuce Mess Team who were preparing a hot meal for the battalion. It would be the first hot meal in six days for the Triple Deuce. Later we would learn everyone said they were getting hot meal because the "Old Goats" were visiting. Not true but knowing how Jim May and **Pete Garwocki** would handle it...we did not deny the perception! CSM then took us over to TOC where we met the battalion staff heavy in planning for the next combat operation. We learned that both Alpha and Charlie companies had engaged and defeated the "bad guys" earlier in the day. Also that Bravo Company was at live fire exercise Sunday "outside the box" and would return on Monday.

After seeing everything in the Bn area LTC Schexnayder said he was going to visit with Alpha and Charlie companies and invited us to tag along. Both were located in the small towns "inside the box" they had liberated earlier in the day. (Today's TIGERLAND is made up of a series

of towns reminiscent of Iraq/Afghanistan much like we had VC villages in our day) Getting down to Alpha first it was great to visit with 1SG Cunningham, Cpt Willams and my brothers of Alpha. Skip and I moved down into the wood line defensive positions to talk with the them. ("Inside the box" is real world play so we tried not to distract them from their exercise tactics) Not wanting to hold up things LTC Schexnayder then proceeded to take us a couple miles down the road to link up with Charlie Company and their new commander. Again we had the opportunity to snap a few photos and visit with troops before we had to move out again. As any TIGERLAND alumnus remembers it does get dark quickly among the tall pine trees of Louisiana and we needed to get back to the battalion TOC.

We made it back to Bn TOC just before dark. CSM and XO invited us to stay for dinner and they got zero argument. The hot meal was delicious and Skip captured a photo of it. Skip (a.k.a THE NIGHTFIGHTER) and I ate off the tailgate of a vehicle. As 2100 hours (that's 9pm to you Pete) approached LTC Schexnayder relayed the battalion had been selected for another mission and headed off with commanders. It was time for the Old Goats to depart the exercise area for the night. (There was a strong rumor JRTC did not want Skip or I "inside the box" wandering around at 2 a.m. looking for a "slit trench" to take a leak. That's our story and we are sticking to it!)

The next morning Cpt Stewart picked us up at 7am at the facility where we were overnight and headed us back "inside the box". It had been 32 degrees overnight and fresh coat of frost was everywhere. As we arrived we learned that Bn Cdr and Bn CSM were to be part of a media interview with local leaders and reporters at one of the towns. (NOTE: We will have a map at Syracuse showing all the areas talked about "inside the box" but for OpSec reasons I chose not to list them)

Major Allie Scott, Public Affairs Officer (PAO) for TF2 met us at the town as we awaited arrival of LTC Schexnayder and CSM Fortenberry to be

interviewed. We had the chance to meet and thank LTC(P) Schroeder Senior TF Cdr and really the one who wired our visit together on short notice.

While waiting for the media conference Skip asked Cpt Stewart to walk us around to see some of the tactical equipment and new weapons on display. Skip put on Stewart's tactical equipment including steel pot and we shot some photos. I passed on the opportunity to suit up. We did get to see the new "Rat Patrol" vehicle which Jim May would have loved for convoy security. Got a good photo of that for all to see. We also observed Air Force cargo planes landing "inside the box" simulating resupply operations. Skip got pictures of that too. Lots of activity in small area.

Once all the players arrived there was a simulated press conference with Bn command element asked questions. Reporters were very tricky in the way they tried to back LTC Schexnayder and CSM into a corner. After the event the PAO and TF Senior Cdr gave LTC Schexnayder and CSM Fortenberry big "thumbs up" for the way they answered questions, etc. They are well versed on how to handle the media.

Triple Deuce command element left us and headed back to continue planning for a tough attack on a fortified position that would begin early Tuesday morning. We said our farewells and thanked them again for the chance for we "OLD GOATS" to visit. (NOTE: New CSM is avid golfer and wants in our Society tourney in September)

In the time remaining Monday afternoon, Maj Scott (PAO) took us over to Brigade TOC where we had the chance for short visit with Bde CSM who was working feverishly. He pointed out where Col **Frederick O'Donnell** 1BCT Cdr and 10th Mountain Division Asst Division Cdr Brigadier General **Michael Howard** were sitting and said he would get us over to see them. (We had visited with both at the Army Birthday Celebration at Ft Drum last June) Unfortunately about
